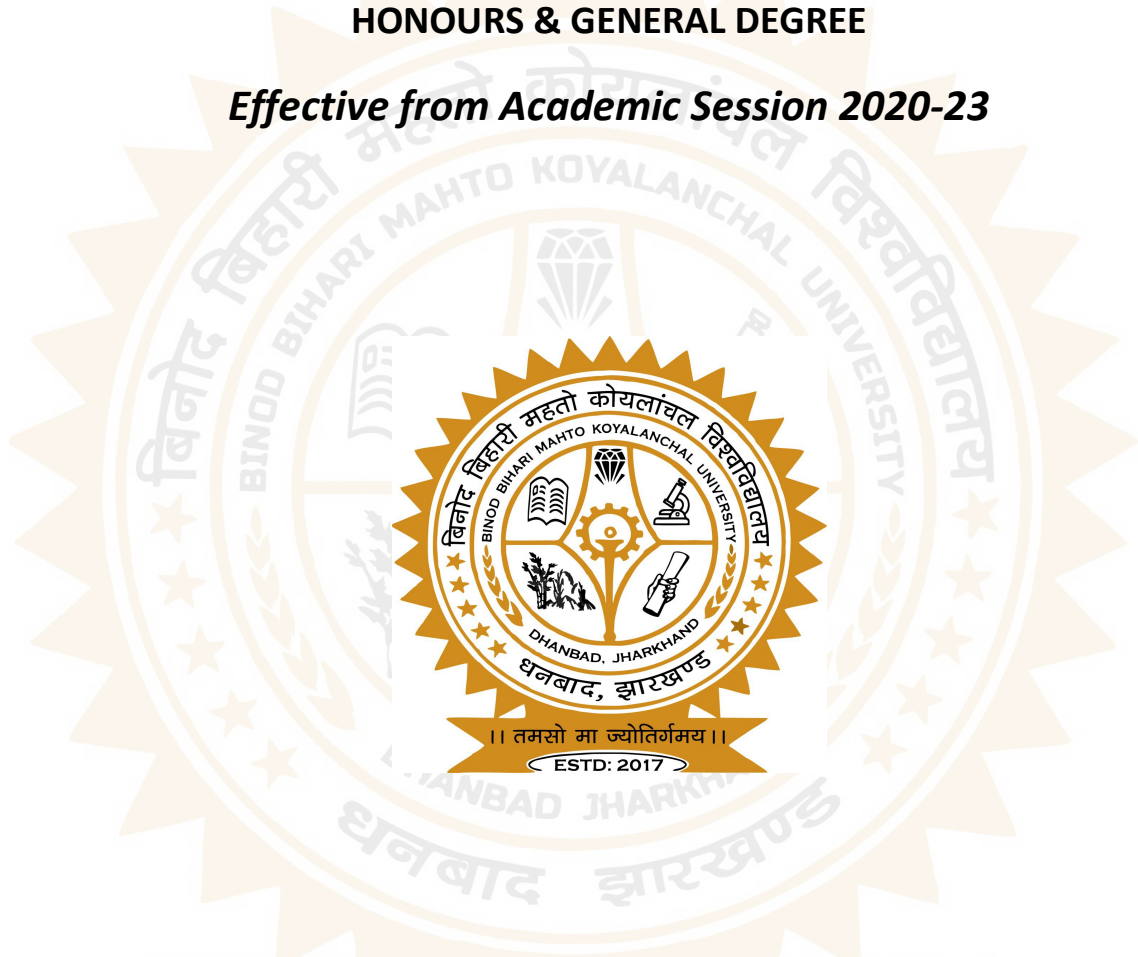

- 1. Preamble:** The University Grants Commission (UGC) has initiated several measures to bring equity, efficiency and excellence in the Higher Education system of country. The academic reforms recommended by the UGC in the recent past have led to overall improvement in the Higher Education System. However, due to a lot of diversity in the system of Higher Education, there are multiple approaches followed by the Universities towards examination, evaluation and grading system. The 'Grading System' is considered to be better than the conventional 'marks system' and hence it has been followed in the top institutions of India and abroad. So, it is desirable to introduce uniform grading system in the University. This will facilitate students' mobility across Institutions, within and across countries, and also enable potential employers to access the performance of students. To bring the desired uniformity in Grading System and in method of Computing the cumulative Grade Point Average (CGPA) based on the performance of the students in the examinations, the UGC has formulated guidelines. University Grants Commission has come up with the Choice Based Credit System (CBCS) programme where students can not only learn core subjects but also explore additional avenues of learning beyond the core subjects for holistic development of an individual.

The Choice Based Credit System (CBCS), an internationally acknowledged system, have following aims: (i) to make the course curriculum learner centric, (ii) to encourage interdisciplinary without disturbing the domain centric knowledge, (iii) to promote mobility of the students and help in optimizing learning, (iv) to allow autonomy to the teachers to built in accountability, (v) continuous evaluation of students to help in optimizing learning, (vi) to introduce transparency in the evaluation systems, (vii) to improve employability of students.

The proposed curriculum of BBMKU endeavours to empower the students and help them in their pursuit to achieve overall excellence. The implementation of CBCS will also facilitate benchmarking of courses in India with leading international academic practice. The CBCS curriculum has been envisaged to give flexibility to learners to learn subjects of their choice at their own pace. In addition to dedicated focus on a discipline through core papers, whether an Honours or General programme, the elective papers which will give students the freedom to choose the allied/applied/broad areas of their discipline and also the areas of other discipline of their interest, have been added. The course will be evaluated by marking system along with the grading system.

- 2. Aims and Objectives:** In accordance with the guidelines issued by the University Grants Commission, this regulation provides procedure of admission, basic frame work of curriculum, examination, evaluation and award of B.A./B.Sc./B.Com Honours and General Degrees to students opting for full time Three Years (six Semesters) Degree Course under **Choice Based Credit System** (CBCS) under Semester mode of teaching in Binod Bihari Mahto Koyalanchal University, Dhanbad.

3. Short Title, Extent & commencement

- (a) This regulation shall be known as 'Three Years (six Semesters) Degree Course Regulation 2020.
- (b) Extent: The regulation shall extend to the territorial jurisdiction of the University and the teaching of the courses for these Degrees shall be carried out through the Constituent Colleges/State Govt. Colleges and Affiliated Colleges within its jurisdiction, having affiliation in the concerned subject(s).

(c) This shall come into force from the academic session 2020.

4. Definition:

(a) 'Course' means a subject.
(b) 'Core Course (CC)' means a compulsory subject chosen by the student as core requirement of the subject chosen from subjects enlisted in **Table-1**. It comprises of two courses:

- **Honours Course (HC):** these courses belong to a subject in which student receives degree of Honours.
- **Discipline Specific Elective Core Subjects (DSE):** these courses belong to Honours specific elective subjects opted by a student from allowed subject combination along with the Honours Course Subject during **Semester-V and VI**.

(c) 'Generic Elective (GE) Course' means a course which can be chosen from a pool which may be specific/ supportive to the subject or nurture the candidate's proficiency/skill. An elective course chosen generally from an unrelated discipline/subject enlisted in **Annexure-2** and shall be a subject other than the core subject opted for.

(d) 'Ability Enhancement Compulsory Course' (AECC): A compulsory course designed to enhance communication ability and environmental concern comprising i) English/MIL Communication & ii) Environmental Science.

(e) 'Skill Enhancement Course' (SEC): A course designed to enhance/provide skill in a field chosen by the candidate from the alternatives enumerated in the **Annexure-1**.

(f) 'Project/Dissertation': 'Project' means work undertaken to acquire special/advanced knowledge in a particular field under the supervision of a teacher; the report of the details of the project is 'Dissertation'.

(g) 'Credit': The term 'credit' refers to the weightage given to a course, usually in terms of the number of instructional hours per week assigned to it. It is a fixed teaching hour course. 'Credit Hours' means hours of teaching. **Contact Hour (CH)** is in correspondence to the **Credit value**. For example, a theory paper having **4 Credits** shall have a minimum of **4 Contact Hours** in a week. For Practical classes and Field Work every **Two Hours** shall make **1(one)** Contact Hour. One Contact Hour shall normally be of **60 minutes** duration.

- **One credit** = 15 Hours of teaching i.e., 15 Credit Hours
- **One credit** = 30 Hours of Practical work

Illustration: in **15** working weeks in a Semester, a paper having **4 Credits** shall have a total of **15x4 = 60 CH**.

Credit Point (P): It is the value obtained by multiplying the grade point by the credit.
($P = G \times C$)

(h) 'Week' means a 6 days working week consisting of minimum 30 working hours.

(i) 'Academic Year' means program session from July to June divided into two Semesters.

(j) 'Semester' means six months teaching and evaluation as part of the total program. A Semester normally comprises 15 teaching weeks and 5 weeks for the conduct of examinations and evaluation.

An academic year comprising 180 working days in the least is divided into two Semesters, each Semester having at least 90 working days. With six working

days in a week this would mean that each Semester will have $90 / 6 = 15$ teaching/ working weeks. Considering that each teaching day has 5 teaching/ working hours, a teaching week would have $5 \times 6 = 30$ working /teaching hours and each Semester will have $30 \times 15 = 450$ teaching hours available for each student.

- (k) 'Modern Indian Language' (MIL): The following shall be treated as Modern Indian Language for the purpose of this Regulation: Hindi, Bengali, Urdu, Khortha, Kurmali and Santhali.

- * Teaching and examination of these subjects shall be held under their specific regulations.

5. Duration

- (a) Three Academic sessions divided into six Semesters. The duration of Semester **I, III** and **V** shall be from July to December (**6 months**). The duration of Semester **II, IV** and **VI** shall be from January to June (**6 months**).
- (b) A candidate who fails to clear all the Semester examinations in a maximum period of six academic sessions (i.e. 6 years) from the date of his/her first admission in first Semester shall have to take admission in the first Semester afresh, if he/she desires the degree.

6. (a) Total Minimum Credits Required

- (i) Honours Course: 140
Details of distribution of credits appear in the Table 4 & 7.
- (ii) Pass Course: 120
Details of distribution of credits appear in the Table 5, 6, 8 & 9.

(b) Total Marks:

Honours	-	2400
General	-	2100

- (c) **Pass Marks:** A minimum of 40% in **theory and practical papers** separately in each paper; and 50% in the **dissertation paper**. (Table 12)

7. Eligibility Criteria for Admission in B.A./B.Sc./B. Com./Vocational Courses

(a) Honours Course:

- (i) A student who has passed the +2 Examination of the 10+2 system or an equivalent examination of a recognized University/Board with a minimum of 45% marks in the concerned subject or in an allied subject[†] shall be eligible to seek admission.
- (ii) A student who has earned a three years Certificate or Diploma in any Professional Course of a recognized institution after 10th level with at least 45% in the aggregate at Certificate or Diploma level shall also be eligible to seek admission.
- (iii) A student who has passed the +2 examination of the 10+2 system or an equivalent examination in Science with at least 45% marks in the aggregate at +2 examination shall be eligible for admission to B.A. (Hons)/B.Com. (Hons) 1st Semester.
- (iv) A Student who has passed the +2 examination of the 10+2 system or an equivalent examination in Commerce with at least 45% marks in the aggregate at +2 examination shall be eligible for admission to B.A. (Hons) 1st Semester.
- (v) A student who has passed the +2 examination of the 10+2 system or an equivalent examination in Arts with at least 45% marks in the aggregate at +2 examination shall be eligible for admission to B.Com. (Hons) 1st Semester.
- (vi) A student who has passed the +2 examination of the 10+2 system or an equivalent examination in Arts or Commerce with at least 45% marks in the aggregate at the +2 examination shall be eligible for admission to B.Sc. (Hons) 1st Semester provided the candidate proves an aptitude for Science by passing

an entrance examination to be conducted for the said purpose by the concerned college.

- (vii) A student who has passed the +2 examination with at least 45% in the aggregate in any faculty is eligible for admission to B.A. (Hons) 1st Semester in Philosophy, Anthropology, Home Science, and Sociology, any language including tribal language, or any other subject in which teaching at +2 level is scanty or unavailable as a core subject.
- (viii) A student who has passed the +2 examination with at least 45% in the aggregate in Faculty of Science is eligible for admission to B.Sc.(Hons) 1st Semester in Anthropology, Home Science, Geology, Statistics or any other subject in which teaching at +2 level is scanty or unavailable as a core subject.
- (ix) A college can also conduct entrance examination for admission to one or all the three-year degree courses as an alternative method of admission.

(b) General Course:

A candidate belonging to any of the categories (i) to (viii) mentioned above shall be eligible to seek admission in similar courses but there shall be no constraint of minimum marks in any case as has been laid down for Honours Course.

†Allied Subjects: The following shall be treated as allied subjects for this purpose

1. Sociology, Anthropology
2. Ancient Indian History, Asian Studies and History
3. Rural Economics, Applied Economics, Labour Economics
4. Microbiology, Biotechnology/ Botany, Zoology/Chemistry
5. Mathematics, Statistics.

8. Regulations for Admission

(a) Regulations for Admission: Admission to a B.A/B.Sc./B.Com Honours/General course with core, DSE, GE, AECC, SEC, Project of choice can be taken at any Constituent/ State Govt. or Affiliated College having affiliation for teaching the subject of choice, provided, facilities of teaching such subject of choice is available in the college and the aspirant student is selected for admission in the college.

(b) Method of Admission: The admission to the 1st Semester of Bachelor Course shall be made through Chancellor Portal or on the basis of a merit list prepared on the basis of marks obtained by the bonafide candidates in the last qualifying examination, or on the basis of the written entrance test to be conducted by the University/College for the purpose, after applying reservation policy and awarding weightage, if any.

9. Reservation and Weightage:

9.1 Reservation:

A) The reservation of seat will as per the following table:

- B) The Caste and other Certificates on the basis of which the student claims reservation should be issued by relevant authorities of Jharkhand.
- C) The vacant reserved seats shall be filled up in the following manner –
- i) Against the vacant seats of ST, the SC candidates if available, be admitted.
 - ii) Against the vacant seats of SC, the ST candidates if available, be admitted.
 - iii) If no candidates of SC and ST are available for admission, the vacant seat will be filled in the following preference:
 - a. BC-I
 - b. BC-II
 - c. General
 - iv) Against the vacant seats of EWS, general candidate will be admitted.
- D) Reserved category applicants selected on the basis of open merit will be counted against the 40% unreserved seats, not against the reserved seats.
- E) Criteria of Income for EWS:**
- i) Persons who are not covered under the scheme of reservation for SCs, STs and OBCs and whose family has gross annual income below Rs.8.00 lakh (Rupees eight lakh only) are to be identified as EWSs for benefit of reservation. Income shall also include income from all sources i.e. salary, agriculture, business, profession, etc. for the financial year prior to the year of application.
 - ii) persons whose family owns or possesses any of the following assets shall be excluded from being identified as EWS, irrespective of the family income:-
 - (a) 5 acres of agricultural land and above,
 - (b) Residential flat of 1000 sq. ft. and above,
 - (c) Residential plot of 100 sq. yards and above in notified municipalities,
 - (d) Residential plot of 200 sq. yards and above in areas other than the notified municipalities.
 - iii) The property held by a “Family” in different locations or different places/ cities would be clubbed while applying the land or property holding test to determine EWS status.

- iv) The term “Family” for this purpose will include the person who seeks benefit of reservation, his/her parents and siblings below the age of 18 years as also his/her spouse and children below the age of 18 years.

9.2 Weightage/Merit Points:

For preparing merit list, percentage of marks will be added to the relevant marks obtained by the eligible candidate in the subject concerned as per the following table:

9.3 No candidate shall be provided two or more benefits at the same time.

9.4 Supernumerary Quota:

A) Persons with Disabilities (PWD Quota):

- i) **3%** Seats over and above the sanctioned strength, shall be reserved for differently abled persons (Persons with Disability) which will be distributed as below:
 - (a) Persons with vision impairment : 1%
 - (b) Persons with hearing impairment : 1%
 - (c) Persons with locomotors disability or cerebral palsy : 1%
- ii) The distribution in the clause i) above is interchangeable in case of non-availability of candidates in the sub-categories.
- iii) The disability to avail the PWD quota should not be less than 40%.

B) Children/Widows of the eligible Armed Forces Personnel (CW Quota)

- i) **5%** Seats over and above the sanctioned strength shall be reserved for CW quota.
- ii) The seats will be awarded in the following priorities:
 - (a) Widows/Wards of Defence personnel killed in action;
 - (b) Wards of serving personnel and ex-servicemen disabled in action;

- (c) Widows/Wards of Defence personnel who died in peace time with death attributable to military service;
- (d) Wards of Defence personnel disabled in peace time with disability attributable to the military service; and
- (e) Wards of Ex-servicemen personnel and serving personnel including personnel of police forces who are in receipt of Gallantry Awards.

C) Foreign Nationals

- i) 5% seats over and above the sanctioned strength in each course shall be reserved for Foreign Nationals.
- ii) The foreign nationals seeking admission in the University/its colleges shall have to get themselves registered with the Foreign Students Registry (FSR) in compliance with the schedule notified by the FSR.

D) Qualifying Degree from Foreign Board:

- i) 3% seats over and above the sanctioned strength in each course shall be reserved for Foreign Nationals.
- ii) Applicants who have passed the qualifying examination (12th or Equivalent) should bring a Certificate from the respective Embassy mentioning the equivalence of their examination to the Indian Secondary Examination.

E) The total number of seats allotted to colleges shall be fixed as per the University Laws.

10. Fee Structure: The candidate shall have to pay all kinds of fees fixed by the Academic Council of the University at the commencement of each Semester, the examination fee for end Semester examinations shall have to be paid if the candidate is found fit to take the end Semester examination. The University shall have rights to revise/charge any kind of fee any time. The fee structure for NRI and Foreign Nationals shall be fixed in terms of U.S. dollar separately through notification.

12. (A) Promotion Criteria:

- (i) To pass a paper, the student must secure separately at least 40% marks in internal and 40% in external examinations of that paper.
- (ii) No student will be detained in odd Semesters (I, III & V).**
- (iii) To pass the even Semesters (II, IV & VI), the candidate must get not less than 4.0 CGPA, apart from other criteria.**
- (iv) To get promotion from Semester-II to Semester-III a Student will be required to pass separately in at least 50% of the papers of Semester-I & II taken together (**Core course (CC), Ability Enhancement Compulsory Course (AECC) and Generic Elective (GE) Course**). A candidate who secures less than 4.0 CGPA in the aggregate of Semester-I and Semester-II shall be declared fail in Semester –II. However it will be necessary to procure pass marks in each of the paper before completion of the course.
- (v) To get promotion from Semester-IV to Semester-V an **Honours Student** has to pass in minimum 12 papers out of the total 18 papers (**Core course (CC), Ability Enhancement Compulsory Course (AECC), Generic Elective (GE), Discipline Specific Elective (DSE) and Skill Enhancement Course (SEC)**) taken together of Semester I, II, III & IV and a **General/Pass Course Student** has to pass in minimum 10 papers out of the total 16 papers (**Discipline Specific Choice (DSC), Ability Enhancement Compulsory Course (AECC), Discipline Specific Elective (DSE) and Skill Enhancement Course (SEC)**) taken together of Semester I, II, III & IV.
- (vi) **Progression to the Next Semester:** The student shall be allowed to appear at the VIth Semester examination only if he/she has cleared all the papers/subjects up to the IIIrd Semester. If a student has backlog papers in IVth and Vth Semester and cleared the VIth Semester, the results of the candidate (who has passed the VIth Semester examination but not passed the lower Semester examinations) shall be declared as NCL (Not Completed Lower Semester Examinations). Such candidates shall be eligible for the Degree only after completion of all the lower Semester examinations within the stipulated maximum time period. Such candidate shall be admitted to the Degree of the year in which he/ she has finally cleared all the papers, but the name of such student shall not be incorporated in the merit list.

The merit list and ranking thereupon shall be prepared only for Regular Examinees, who passed the Examination in single attempt.

(B) Distribution of Marks: The Total Marks, Marks allotted for External & Internal Examinations and respective minimum pass marks are as under:

- (i) All theory or practical papers in each Semester shall be treated as a separate paper and the examinees will be required to pass in theory and practical papers separately. If examinees fail in theory or practical or in both papers, he/she will appear in the next University End-Semester examination.
- (ii) **There will be no supplementary examination in any Semester.** Further, if an examinee fails in theory or practical papers he/she will be given **three consecutive attempts** to clear the paper. Under special circumstances, a particular case may be taken to the Examination Board for the final decision.

13. Attendance Rules

- (a) All students must attend every lecture, practical/tutorial class and other activities of the College. However, the attendance requirement will be a **minimum of 75%** of the classes actually held.
- (b) A student must inform the Head/Principal concerned immediately of any instance of continuous absence from classes with the valid reason thereof.
- (c) A student who is absent due to illness should approach the teachers concerned for makeup quizzes, assignment and laboratory work.
- (d) A student who has been absent from a Mid-Semester/Internal Examination due to illness or for some other valid reason shall approach the teacher concerned for makeup test immediately on return to class. The request should be supported with a medical certificate issued by a registered medical practitioner/affidavit.
- (e) In case the period of absence on medical grounds is more than 20 working days during the Semester, a student may apply for withdrawal from the Semester. Such application must be made as early as possible. No applications for Semester withdrawal will be considered after External examination have commenced. Partial withdrawal in a Semester is not allowed.
- (f) If a candidate represents his/her institution/University/Jharkhand State/Nation in Sports/ NCC/ NSS/Cultural or any officially sponsored activity, he/she may be permitted to claim attendance for the actual number of days participated, based on the recommendation of the Head of the Institution concerned. If a candidate is

selected to participate in national level events such as Republic Day Parade etc, he/she may be permitted to claim attendance for the actual number of days participated (including journey days) based on the recommendation of the head of the Institution concerned.

- (g) If a student is continuously absent from the institute for more than four weeks without permission of the Head of the Department concerned, his/her name will be removed from institute rolls.
- (h) In extraordinary cases the Vice-Chancellor can utilize his discretionary power to condone the shortage of attendance.

14. Syllabi

(a) **Basic Framework of Syllabus:** The syllabus in each subject and in each paper shall be demarcated into well-defined units/areas of content along with a topic-wise break up. The Board of Studies of the subject concerned constituted by the Vice-Chancellor shall be responsible for framing the Syllabus subject to the provisions of this regulation.

(b) **Symbol of Paper: XYZ-H-C-101-T:** The first three symbols in Roman capital letters indicate the subject; the next symbol H or G indicate Honours or General course; the next symbol(s) denotes Core (C), Generic Elective (GE), Discipline Specific Elective (DSE), Discipline Specific Choice (DSC), AECC, SEC, etc. Out of the next three digits, the first digit indicates the Semester e.g. 1,2,3,4,5,6 for Semester I, II, III, IV, V, VI respectively, and the next two digits indicate paper number. The last letter T or P indicates Theory or Practical.

16. Medium of instruction and Examination

Except language subjects, the medium of instruction/examination shall be Hindi/English.

17. Examination, Evaluation and Declaration of Results

- (a) The duration of a theory paper of an End-Semester Examination shall normally be **three hours** and that of a Mid-Semester Examination **one and half hours**. Practical paper will be of **three hours** duration in both Mid-Semester and End-Semester Examinations.
- (b) **Assessment and Progression:** The performance of a student shall be evaluated through Internal Assessment that will include the Mid-Semester Examination on the pattern of the End-Semester Examination, **regularity of attendance and other activities, carrying 20% marks** in all. **The End-Semester Examination shall carry 80% marks.**
- (c) **Activities for Internal Assessments:** The Internal Assessment for 20% marks of a paper shall be made in the following categories of activities:

Evaluation of Day to Day Assessment including Extracurricular Activities (2 Marks):

The student's performance shall be examined by the staff in-charge of extension activities along with the Head of the respective department and a senior member of the Department on the following parameters.

- 20% of marks for quizzes/assignments/participation in seminars, behaviour, etc.
- 60% of marks for active participation in classes/camps/games/special camps/programmes in the college/district/state/ University activities.
- 10% of marks for exemplary awards/certificates/prizes.
- 10% of marks for other social components such as blood donation, Fine Arts, etc.

The above activities shall be conducted outside the regular working hours of the college.

If a differently able student is unable to participate in any of the above activities, he/she shall be required to take a test in the theoretical aspects of any one of the above.

(d) Conduct of Mid-Semester Examination

- (i) The Mid–Semester Examination of all theory papers of the Honours and General courses shall be of **one and half hours** duration per paper. The concerned Principal of the College shall fix the programme of the Mid-Semester examination and it shall be conducted by the Examination Department of the College with the help of the concerned Head of the Department of the college, preferably in the month of March and September.
- (ii) **If a student misses the Mid-Semester Examination** due to some valid reason (to be ascertained by the Head of the Department of the college on the basis of documentary proof provided by the student), the Examination Department of the College may arrange a special Mid-Semester examination for such student. However, only one such special Mid-Semester examination shall be held for all such cases and it should be conducted within one month from the date of completion of the Mid-Semester examination.
- (iii) **Completion of Internal Assessment:** The marks of the internal assessment shall be published on the notice board of the college for information of the students. It shall be the responsibility of the Principal of the College to submit the marks of the Internal Assessment of the students of the college well before filling the examination form of the End–Semester Examination.
- (iv) **Evaluation:** Evaluation of the answer-scripts of a Mid-Semester Examination shall be done by the teacher(s) who have taught the concerned portion of the paper, within 15 working days. A tabulation register shall be maintained in each department in which these marks (written + attendance and day to day activities) will be tabulated, marks foil containing the amalgamated marks of all the portions of the internal assessment (paper-wise) shall be sent in duplicate to the Examination Department of the college for transmission of one copy to the Examination Department of the University.
- (v) Internal assessment marks shall be shown separately in the marks card of final examination after the End-Semester Examination. A candidate, who has failed or rejected the result, **shall retain the internal assessment marks for the next examination.**

(e) Holding and Evaluation of End Semester Examination

(i) Eligibility criteria for End–Semester Examinations:

- (a) A student shall be deemed to have qualified to appear at the End- Semester Examinations only if he/she secures **minimum qualifying marks in the**

Internal Assessment, fulfills the prescribed attendance criteria, has cleared all the dues, filled in the examination form in time, deposited the prescribed examination fee on time and possesses good moral character.

- (b) If a student failed to secure pass marks in both Mid-Semester & End-Semester separately, he/she will be required to reappear in End-Semester Examination of following Sessions within period of Upper Limit of Six Years from the date of admission.
 - (c) If a candidate/student has not appeared in the Mid-Semester Examination organized at college level, he/she will not be eligible to fill up the End Semester Examination Form for End Semester Examination to be organized at University level for that Semester.
 - (d) A student will not be allowed to repeat the Mid-Semester Examination if he/she has appeared once in the Mid-Semester Examination organized by the college/institution.
- (ii) No candidate will be normally permitted to appear in the examination without a valid Admit Card. In case the candidate reports to the examination hall without his/her Admit Card despite the fact that he/she was issued Admit Card and it was not forfeited for adopting unfair means, the Center Superintendent may at his/her discretion provisionally permit the candidate to appear in the examination after satisfying himself/herself about the bonafide of the candidate by taking his/her thumb impression/several signatures for further verification or a measure which he/she thinks appropriate. The conduct of examination shall be governed by the provisions contained in **Jharkhand Conduct of Examinations Act, 2001**.
- (iii)(a) **Question Paper Setting and Evaluation:** The responsibilities of question setting, conduct of examination, evaluation, and publication of results shall lie on the authorities vested with such powers in the University Act. However, The Head of the concerned University Department shall assist the Examination Board in these processes including providing a panel of paper setters and evaluators. The Head of the concerned Department shall also be responsible for carrying out moderation of results before recommending with comments to the Examination Board for publication of the results. The Vice-Chancellor may exercise the functions of the Examination Board in anticipation of the approval of the Board.
- (b) (i) **Nature and Type of Questions:** There will be two groups of questions namely **Group A** and **Group B**. An Honours Paper/General Course Theory Paper shall generally comprise **nine questions** of equal value. **Five questions will be required to be answered**. **Group A** shall comprise of multiple choice questions (objective type questions) and short answer type questions and will be all compulsory. **Group B** will contain long answer type questions. The setter shall set the question to test the analytical and descriptive skill of the student through the paper. The duration of a theory and practical papers of an end-Semester examination shall be **three hours**. **Format of question papers of End-Semester Theory Examination is given in Annexure -3.**

Distribution of marks in practical paper of an End-Semester Examination will be of 60% in performance of experiment, 20% in record/note book and 20% in viva-voce.

(ii) Moderation of Question Papers: The questions set by setters may be subjected to moderation by a Moderation Board of the subject specially constituted for the purpose by the Vice-Chancellor.

The purpose of moderating an examination is to help ensure that it achieves the normal goals of end-of-course assessment. Obvious things to check include the following:-

1. Do the questions unambiguously communicate the examiner's intentions? i.e., could a student sitting the exam reasonably be expected to know what is required of him?
2. Are the questions completable in the time allotted?
3. Is the marking scheme sufficiently detailed to allow efficient and consistent marking?
4. Does the examination fairly cover the syllabus?
5. Are there any technical (e.g. mathematical) errors?
6. Could the writing style be improved?

(c) Requirement of Passing in different types of evaluation: Passing in Theory (written), Internal, Practical and examination of Dissertation separately is essential.

(d) Submission of Record Notebooks for Practical Examinations: A candidate appearing for a practical examination must submit the bonafide Record Notebooks prescribed for the practical examinations otherwise he/she shall not be permitted to appear at the practical examination.

(e) Concession given to the Persons with Disability (PWD) in Examination (Internal & External): The following concessions are admissible to the Persons with Disability (PWD):

- (i) Permission to use an amanuensis;
- (ii) The amanuensis should be a student of class lower and different discipline than the one for which the candidate will be taking the examination;
- (iii) The Centre Superintendent of the Examination Center shall choose a suitable amanuensis and forward his/her particulars to the DSW /controller of Examination for consideration and approval;
- (iv) The candidate shall pay the fee as prescribed for use of the amanuensis. However, the Dyslexic, Blind, Physically Handicapped or Spastic or Candidate should be provided services of an amanuensis free of cost;
- (v) The amanuensis shall be paid remuneration as prescribed from time to time by the University;
- (vi) The candidate may be permitted to use the services an amanuensis in all or any of the papers.
- (vii) Additional time of 30/60 minutes in each paper in internal & external examination, respectively;

- (viii) The Center Superintendent shall make the sitting arrangements for the Dyslexic, Blind, Physically Handicapped and Spastic candidates on the ground floor, as far as possible;
- (ix) Any other special arrangement, as necessary, shall be made by the Centre Superintendent(s) under intimation to the DSW / Controller of Examination.

18. Preparation of Results: An examinee’s performance shall be evaluated in terms of Letter Grades, Grade and SGPA in a Semester and CGPA in all the Semesters taken together. **Students’ final marks and the result will be based on the marks obtained in Mid Semester and End Semester Examination organized taken together. Each Semester result shall be declared in terms of grades.** The score card of each Semester shall comprise paper wise number of credits, letter grade, grade point and SGPA. A ten point grading system which is based on the actual absolute marks scored as described below shall be adopted.

19. Computation of SGPA and CGPA

19.1 Calculation of Semester Grade Point (SGPA)

- (a) The SGPA is the ratio of sum of the product of the number of credits with the grade points scored by a student in all the courses taken by a student and the sum of the number of credits of all the courses undergone by a student, i.e.

$$SGPA (S_i) = \sum(C_i \times G_i) / \sum C_i$$

where C_i is the number of credits of the ith course and G_i is the grade point scored by the student in the ith course.

- (b) The CGPA is also calculated in the same manner taking into account all the courses undergone by a student over all the Semesters of a programme i.e.

$$CGPA = \frac{\sum(C_i \times S_i)}{\sum C_i}$$

where S_j is the SGPA of the j^{th} Semester and C_j is the total number of credits in that Semester.

- (c) The SGPA and CGPA shall be rounded off to 2 decimal points and reported in the transcript.

19.2 Announcement of Results: The University shall announce results on the recommendation of the concerned Head of the Department Institution- or College-wise under following classification:

19.2.1 A candidate shall be declared to have passed the UG program if he/she secures at least an aggregate CGPA of 4.0.

19.2.2 **Declaration of Classes on the Basis of CGPA grade shall be announced.**

(Table-17)

19.3 Classification of Successful Candidates for the award of Bachelor Degree

(a) The results of successful candidates at the end of VI Semesters shall be classified on the basis of aggregate percentage of marks obtained in all the six Semesters and the aggregate or Cumulative Grade Point Average (CGPA) for the award of Bachelor Degree in Arts, Science and Commerce.

(b) Candidates who pass all the Semester examinations in the first attempts in Three Academic Years or Six Semesters are eligible for ranks.

(c) A candidate who passes the Semester examinations in parts is eligible for only Class and not for ranking.

20. Scrutiny and Re-evaluation

- 20.1 Scrutiny and re-evaluation of the answer script shall not be ordinarily allowed. However, on the advice of the concerned Head of the Department the Vice-Chancellor can order for the re-evaluation in exceptional cases where prima facie incongruities in evaluation are apparent.
- 20.2 A student can apply for the scrutiny of his/her answer script, after paying the prescribed fee within 15 days of the receipt of the marks. The paper shall be scrutinized by the Examination Department of the University with the assistance of the Head of the concerned Department. Scrutiny shall be done to rectify unmarked portion/wrong transcription, if any.

21. Improvement in Results: A student who has cleared all the papers of a Semester examination in one attempt may appear in maximum of two papers for improvement in results in the next examination of that Semester, after filling in the examination form along with the prescribed examination fee. Marks obtained by the examinee in the earlier examination in the paper in which improvement is sought shall be retained if the candidate fails to improve his/her marks. The provision of improvement shall be available in all the Semesters. The facility of improvement shall not be available to a candidate in the Semester in which the candidate has failed to clear all the papers in one attempt.

22. Credit Transfer Policy

Recognition/Accumulation (Credit Bank)/Transfer of Credits

BBMKU facilitates transfer of credits through an evaluation process. Requests for Transfer of Credits can be categorized as below:

(a) Taking Courses Outside while Enrolled in BBMKU (Under Collaboration)

Current BBMKU students who are considering taking course(s) at another institution should obtain permission from their Principal/HOD. The information has to be sent to Dean, Students' Welfare (DSW). However, such arrangements require prior collaboration at the University level. Only the institutions signing MoUs for the purpose shall be admissible for the provision.

(b) Taking a Break/Dropping out (due to unavoidable circumstances) during Studies at BBMKU

If a student has to take a break due to unavoidable circumstances during studies at BBMKU (with due permission from the competent authority) but wishes to complete his/her studies at BBMKU, may also get the benefit of transfer of credits earlier earned. Such individuals may route the application through their Principal/HOD. The Principal/HOD shall then arrange for necessary approval from DSW/competent authority.

(c) Course Completed/Done at UGC Accredited Institutions and Other Reputed Institutions

A Candidate can get the benefit of transfer of credits for Graduate-level courses completed at UGC accredited institutions and other reputed institutions such as IITs, IIMs, Central, other State Universities/Deemed Universities NITs, BITs, etc., provided that a grade of at least C of BBMKU (equivalent to 5.0 or above grade point) is earned and the course is similar in content as compared to what is offered at BBMKU.

(d) Course Completed/Done at An/A Institute/University Abroad

Credit earned due to the courses attended in the Universities/Institutes abroad as part of exchange/mobility/scholarships, etc. can be transferred based on the comparison with the equivalent courses at BBMKU. Generally, the Institutions/Universities should be recognized by the Association of Indian Universities (AIU) or UGC. Such universities abroad should have the best accreditation of their country. All grade-cards/transcripts and course syllabi must be translated from the original language into English and certified by a committee (Credential Transfer Committee of BBMKU) and ratified by the Equivalence Committee of BBMKU.

(e) Maximum Credits Allowed to be Transferred

BBMKU will allow a maximum of 2 Semesters' credits for a 3/2 years programme from accredited institutions (of highest accreditation of their country, in case of foreign Universities). Courses must be academic in nature and be similar in scope and content to the courses offered at BBMKU.

23. Transfer of Admission: Transfer of admissions permissible only for IIIrd and Vth Semesters for the students of other universities and within the University.

23.1 Conditions for Transfer of Admission of Students within the University

- (i) His/Her transfer/admission shall be within the intake permitted to the college.
- (ii) Availability of same combination of subjects studied in the previous college.
- (i) He/she shall fulfill the attendance requirements as per the University Regulation.
- (iv) He/She shall complete the programme as per the regulation governing the maximum duration of completing the programme.

23.2 Conditions for Admission of Students of Other Universities for Transfer

- (i) A Candidate migrating from any other University may be permitted to join III/V Semester of the degree programme provided he/she has passed all the subjects of previous Semesters/years as the case may be. Such candidates must satisfy all other conditions of eligibility stipulated in the regulations of the University.
- (ii) His/Her transfer/admission shall be within the intake permitted to the college.
- (iii) He/she shall fulfill the attendance requirements as per the University Regulation.
- (iv) The candidate who is migrating from another University is eligible for overall class and not for ranking.
- (v) He/She shall complete the programme within stipulated period.

23.3 Foreign Nationals

Eligible foreign nationals who have either:

- (i) been selected for award of Government assistantship/fellowship, or
- (ii) been permitted by the Government of India to undergo studies as Self-Financing Foreign Student may also be admitted to any of the courses subject to acceptance of the academic standard of the applicants by the University.

- (iii) However, a foreign national/Non Resident Indian who has passed the qualifying degree examination from any Indian University/Institute and is desirous of admission to any of the courses either with Government of India assistantship/fellowship or as a self financing foreign student may also be eligible under Students outside Jharkhand category.

24. Validity of Registration

Validity of a registration will be for maximum for **Six years** from the date of registration.

25. Moderation (Grace Marks)

- (a) Grace marks will be awarded in theory papers only.
(b) A maximum of 5 marks; only in one paper, only once in complete academic cycle; will be awarded as grace marks.

Grace marks will be awarded in the condition of requirement for the change of status of result viz: *Not-promoted to Promoted* & for *Promoted to Pass*. or If an examinee fails to obtain minimum marks (45%) to secure honours he/she will be awarded maximum five (5) marks as grace marks in one paper.

- (c) Grace Mark will not be awarded for making up shortfall in minimum CGPA or improving the grade.

26. Lateral entry:

- (a) A student who has passed the Diploma Course from the Government Polytechnic and have passed the Intermediate Examination of state Council Board or a recognized University/Board, he/she will be eligible for lateral entry in the **IIIrd Semester** Honours/Pass courses.
(b) A candidate is eligible for lateral entry to **Vth Semester** if he/she possesses Advance Diploma in Arts/Science/Commerce of this University or equivalent thereto obtained after completion of 4th Semester examinations in one attempt in two academic sessions.

27. Removal of difficulties

If difficulty arises in implementing any of the clauses, the Vice-Chancellor shall remove the difficulties.

28. Repeal and Savings

- (i) **Repeal:** The earlier regulation pertaining to Three-Year Degree Course leading to B.A./B.Sc./B.Com Honours and General is hereby repealed.
(ii) **Saving:** Notwithstanding such repeal anything done or any action taken in exercise of the power conferred by or under the said regulation shall be deemed to have been done or taken in exercise of the powers conferred by or under this regulation, as if this regulations wherein force on the date on which such thing was done or action taken.

29. Review

The University can, at any time, review, alter, substitute, amend or delete any of the provisions of this regulation subject to such conditions as may be prescribed by the UGC and as per any special situation arising during the operation of these regulations as felt by **Academic Council of the University**.
